

## OFFICIAL CONTEST RULES AND REGULATIONS

# Univision Canada presents the: “MANA Contest”

**(1) Agreement:** These rules govern the Univision Canada “Mana Contest” on univision.ca. Before entering the Contest, each entrant must review and be subject to the Contest Rules. No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest Rules and the decisions of the Contest Judges. All decisions of the Contest Judges are final. The Contest Rules may be found at univision.ca (the “Website”).

**(2) Sponsors:** The Contest Sponsors are TLN Media Group Inc. and Live Nation

**(3) Eligibility:** The Contest is open to all residents of Ontario, 19 years of age or older, except for employees or contractors, immediate families and anyone living with any employee of the Contest Sponsors or their corporate affiliates, advertising or promotional agencies or affiliates. Incomplete or illegible entries, bulk drop offs, photocopies, scanned copies, facsimiles or other mechanically or electronically reproduced entries will not be accepted and will be disqualified.

**(4) Contest:** The Contest period runs from 9:00 a.m. EST, Monday October 7 2019, to 5:00 p.m EST, Friday, October 11, 2019 (the “Contest Period”). There will be a total of one (1) prize. Top 5 entries will be submitted to the band “Mana” to choose the one winner.

### **(6) Prize:**

Winner will receive 2 tickets to the Toronto show on October 17 (\$414 value), free guitar (\$575 value), Winner (winner only, not guest) will get to go on stage and perform 2 songs (PERRO ENLOQUESIDO and ME VALE). Winner must provide their own transportation to the concert.

The Contest Sponsors are not responsible for late entries and no entries will be permitted before or after the “contest period”. Only one entry per person.
